## Mould Killer & Remover

**Zinsser Mould Killer and Remover** effectively kills and removes mould, fungus and algae. It is ideal for use in bathrooms, kitchens and areas of high humidity and can be used on internal surfaces such as tiles, wood, plaster and wallpaper.

Containing a fungicide that removes mould, it is ideal for preparing mould stained areas before painting to give a better, longer-lasting paint finish.

**APPLICATION** – Always test on an inconspicuous area first. Clean surface thoroughly with Zinsser Universal Degreaser Cleaner or a similar proprietary cleaner in accordance with the manufacturers instructions. Once the surface is suitably cleaned, spray the **Zinsser Mould Killer and Remover** directly on the surface to be treated. Allow the **Mould Killer & Remover** to dry thoroughly before decorating as required.

**COVERAGE** – Up to 15m<sup>2</sup> per litre.

**CLEANUP** – Do not empty into drains or watercourses. Do not contaminate foodstuffs, eating utensils or food contact surfaces. Wash hands and exposed skin before meals and after use. Store in a safe place. Keep away from treated surfaces until dry. For indoor use only.
